Pursuant to Regulations 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") read with Schedule III to the Listing Regulations, this is to inform you that the Board of Directors of the Company, at its Meeting held today, i.e., on Thursday, September 28, 2023 (which commenced at 11.15 a.m. and concluded at 2:00 p.m.), inter alia, has approved / noted the followings:-

- 1. Approved Increase of Authorized Share Capital of the Company from Rs. 20 Crore to Rs. 50 Crore subject to the approval of Members.
- 2. Approved to issue upto 2,55,00,000 (Two Crore Fifty Five Lakh) warrants each convertible into, or exchangeable for, one equity share within the period of 18 (eighteen months) in accordance with the applicable law ("Warrants") at a price of Rs. 55/- (Fifty Five Only) each (including the warrant subscription price and the warrant exercise price) aggregating upto Rs. 1,40,25,00,000/- (One Hundred Forty Crore Twenty Five Lakh Only) to Mr. Kapil Garg, Promoter and Managing Director of the Company and Mrs. Shelly Garg, Mr. Saurabh Garg, Mrs. Pooja Garg, Bima Pay Technology Private Limited ("Promoter Group") and to certain other non-promoter group persons (as listed in Annexure I herein) by way of preferential issue in accordance with the provisions of Section 42 and Section 62(1)(c) of the Companies Act, 2013, as amended ("Act") read with Companies (Prospectus and Allotment of Securities) Rules, 2014, as amended ("Rules"), Chapter V of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, Listing Regulations and such other acts / rules / regulations as maybe applicable and subject to necessary approval of the members of the Company and other regulatory authorities, as maybe applicable ("Warrants Issue"). Upon issue of Warrants in accordance herewith, an amount equivalent to 25% (twenty five per cent) of the total issue size shall be called upfront from the proposed allottees;
- 3. Approved to hold the extra-ordinary general meeting of the members of the Company on Saturday, 21st October, 2023 through video conferencing and / or other audio visual means for seeking member's consent for Increase in Authorized Capital and Warrants Issue; and
- 4. Decided to keep Sunday, 15th October, 2023 as the cut-off date for determining the eligibility of the members entitled to vote by remote e-voting at the ensuing extraordinary general meeting of the Company schedule to be held on Saturday, 21st October, 2023 through video conferencing and / or other audio visual means.


